

National Taipei University of Technology Academic Research Cooperation Epidemic Prevention Measures

Issued on Feb.25, 2020

To reduce the risk of coronavirus disease 2019 (COVID-19) and to maintain the health of all faculty and students, National Taipei University of Technology (Taipei Tech) has taken relevant countermeasures. According to Taiwan Centers for Disease Control's Country Epidemic Level, if there is a need for academic research cooperation, please follow the principles below.

Level 3 : Warning	<ul style="list-style-type: none">● China● Hong Kong● Macao● Korea	For the safety of the campus, please suspend the exchange activities in Taiwan or conduct research exchanges in the country.		1.Starting from <u>February 4</u> , foreign nationals seeking to enter Taiwan for special reasons may apply for an entry visa as long as they have not visited or resided in areas in the <u>People’s Republic of China (including Hong Kong and Macao)</u> severely affected by COVID-19 outbreak. When applying for such a visa, foreign nationals must provide the following documents(*) in order for the Taiwanese overseas mission to process the application in accordance with relevant regulations. 2.Starting from <u>February 25</u> , foreign nationals entering Taiwan from <u>South Korea</u> (except for passengers who transit through South Korea) must undergo a 14-day period of home quarantine.
Level 2 : Alert	<ul style="list-style-type: none">● Japan● Singapore● Italy	Avoid unnecessary exchange activities in Taiwan or conduct research exchanges in the country/area.	If faculty and students must travel to the country, please notify related departments of Taipei Tech and follow precautionary measures. After returning to Taiwan, you must truthfully fill-in the “Novel Coronavirus Health Declaration Card” and implement independent health management for 14 days.	
Level 1 : Watch	<ul style="list-style-type: none">● Thailand● Iran	Evaluating the necessity of exchange activities in Taiwan or conduct research exchanges in the country, and to aware of your own health.		
Other countries not listed above		It is recommended that epidemic prevention measures be followed when conducting exchange activities in Taiwan or research exchanges in the country.	Faculty and students must still take precautionary measures during stay abroad, and pay attention to the updated information of the travel warning issued by Taiwan Centers for Disease Control during the tour. After returning to Taiwan, please truthfully fill-in the “Novel Coronavirus Health Declaration Card.”	

*Notes :

1. Complete travel history comprising the previous 14 days. (Applications submitted by those who have been to severely affected areas in the People's Republic of China, including Hong Kong and Macao, during this period will not be accepted.)
2. Certificate of a health checkup conducted in the previous seven days showing that the applicant does not have a fever of 37.5 degrees Celsius (forehead temperature) or higher and is not suffering from respiratory tract or lung infections.
3. Signed affidavit stipulating that the applicant shall immediately notify health authorities in Taiwan when experiencing any symptoms detailed in paragraph 2.
4. Other documents required for entry visas to Taiwan based on the purpose of visit.

Overseas Emergency Assistance

Our faculty and students who have suspected symptoms of COVID-19 or encounter other safety problems in overseas could ask relatives and friends in Taiwan to contact Ministry of Foreign Affairs at **0800-085095**, its emergency assistance number in Taiwan, or call Taiwan's local representative office for assistance.

Entry Prevention Measures

If fever, cough or other common symptoms of COVID-19 develop upon arriving at Taiwan, please voluntarily notify the quarantine officer at the quarantine station in the airport/port, and follow the instructions given by the airport/port. If the suspected symptoms develop within 14 days after returning to Taiwan, please call the toll-free Communicable Disease Reporting and Consultation Hotline **1922 (0800-001922)**, put on a surgical mask, and follow the instructions given by the hotline to seek medical attention.
